

## NOTES FOR CONTRIBUTORS

### **Submissions**

Articles (which should normally not be in excess of 10,000 words) should be submitted as an e-mail attachment in MS Word to the General Editor, Professor Ewan McKendrick, [ewan.mckendrick@law.ox.ac.uk](mailto:ewan.mckendrick@law.ox.ac.uk). Books for review, reviews and review articles should be sent to Ms G. de Burca, Villa Schifanoia, Via Boccaccio 121, I-50133, Firenze, Italy or Dr Julie Dickson, Somerville College, Woodstock Road, Oxford OX2 6HD. Articles should be accompanied by an abstract of not more than 150–200 words. Footnotes should be marked clearly in the text in numerical order after a point of punctuation, and listed as the bottom of the relevant page.

### **Citations**

Please refer to OSCOLA for citation of legal authorities ([http://www.competition-law.ox.ac.uk/published/oscola\\_2006.pdf](http://www.competition-law.ox.ac.uk/published/oscola_2006.pdf)). References to cases should, as a general rule, give the full correct title of the case where it first appears, but common form abbreviations are acceptable on subsequent references. Very well known cases may be referred to in abbreviated form even on first use, and in cases with very long names, the abbreviated form appearing at the head of the Law Report page is acceptable. In the names of companies, there is no objection to omitting ‘& Co. Ltd’ and similar expressions. References to English cases should always be to the official reports where available. Full stops (abbreviation marks) will be omitted in law reports references, title to journals, titles of judges, and in the names of cases, after the *v* (for versus), and after initials and other parts of names of parties.

Quotation marks should be single and not double unless they indicate a quotation within a quotation.
